**Minutes of 109<sup>th</sup> Weekly Review Meeting held under the Chairmanship of Secretary(WR, RD & GR) on 08.03.2017**

The 109<sup>th</sup> Weekly Review Meeting was held on 08.03.2017 under the Chairmanship of Secretary(WR, RD & GR) in which Review of proposed activities for Swachhta Pakhwara from 16-31<sup>st</sup> March, 2017 were done. Secretary (WR,RD&GR) interacted with KRMB/GRMB, Brahmaputra Board, Regional Office, CWC, Bhopal & GFCC, Patna through Video Conferencing. He emphasized that during Swachhta Pakhwara some major cleanliness drive of public importance after involving general public, school/college students, women etc to be carried out . The following action points were identified for further action :

**KRMB/GRMB**

1. KRMB/GRMB will undertake cleaning activities in Godavari/Krishna River during the Pakhwara. 2 programs in each river each week shall be undertaken. PPA may also be associated for the activities. The details of programs may be furnished to Ministry by 9.3.2017 forenoon.
2. The telemetry work in Godavari/Krishna Basin to be completed by 5<sup>th</sup> May 2017. Member (RM), CWC to ensure that FF stations are working properly by that time. The information required for resolution of issues between AP and Telangana should be available. Shri Pradeep Kumar, Member (RM), CWC and Shri S.K. Halder to personally ensure this.

**Regional Office, CWC, Bhopal**

1. CE, CWC informed that they are undertaking cleaning of two lakes near Bhopal. School/College students and other local residents will also be associated for Swachhta drive. They shall also consult CGWB for associating Mineral Water Plant industry in the drive under CSR.

**Brahmaputra Board**

WAPCOS should focus for some activities in Kochi & Chennai in addition to other places. CMD, WAPCOS shall ensure that the activities identified be got approved from Hon'ble Minister (WR, RD & GR).

NPCC shall go through the programmes of WAPCOS and finalized similar activities. CMD, NPCC shall apprise the details of Swachhta activities to Secretary (WR,RD&GR) by 09 Mar 2017.

UYRB shall send the details of Public activity/program at Wazirabad for the Swachhta Pakhwara to JS (Admn), MoWR by 9.3.2017 forenoon.

**CGWB**

CGWB shall undertake activities in Areas where permission of ground water extraction were given to big industries. Two major activities (one each in 1<sup>st</sup>& 2<sup>nd</sup> week of Swachhta Pakhwara) at each Regional Director level shall be identified and details be submitted to JS (A&GW) by 9<sup>th</sup> March, 2017(FN). Mr. Saha, Member (SAM) shall co-ordinate to ensure successful competition of Swachhta Drive. Mr. Parikh (CGWB) will give details of activities in CGWB labs.

**GFCC, Patna**
