

Minutes of 110th Weekly Review Meeting held under the Chairmanship of Hon'ble MOS(WR, RD & GR) on 15.03.2017

The 110th Weekly Review Meeting was held on 15.03.2017 under the Chairmanship of Hon'ble MOS (Dr.S.K.Balyan) in which proposed activities undertaken by Ministry under Swachhta Pakhwara from 16th - 31st March, 2017 were discussed. Progress of activities of UYRB were also reviewed.

Secretary(WR,RD&GR) briefed Hon'ble MoS that SFC proposal for the protection of Majauli Island with DONER funds has already been approved. Dr. Masood Hussain, Member, CWC mentioned that all statutory clearances for the starting up of Ken Betwa Link project obtained except Forest clearance. Forest department has sought some information which has already been provided. Draft Cabinet note for the Ken Betwa Link has also been prepared.

Commissioner(FM) highlighted that Pancheshwar Multi Purpose project is one of the main project of the MOWR, RD&GR for which DPR was prepared by WAPCOS. A presentation in this regard has also be made before Chief Secretary Uttarakhand, as there are some submergence issue in Uttarakhand. For start of the project, consent of Govt. of Uttarakhand and approval of Govt. of Nepal would also be required. Matter is being pursued for clearance from Ministry of External Affairs .

Comm.(Indus) mentioned that as per the provision of Indus Water Treaty, Meeting of India and Pakistan is required in every 6 months. Next meeting is being held on 20-21 March, 2017 in which issues of 4-5 major projects including Kishen Ganga Hydro Electric project will be discussed. Further, substantial progress in resolving the issues of Shahpur Kandi project between Punjab and J&K has been made with the intervention of Secretary(WR,RD&GR).

The following action points were identified for further action :

1. A Committee may be constituted immediately by Comm.(FM) for the auction of old gates/scrap of FBP.

2. Mr. Sampat, Member, CGWB may be deputed for the cleaning activity by CGWB on 17th March, 2017.

3. NIT, Patna may be associated for Shramdaan and Swachhta Sandesh rally at Gandhi Ghat, Patna, Bihar proposed on 19th March, 2017.

4. A major event/programme shall be organized by CWC at its Headquarter on World Water Day scheduled on 22nd March, 2017.

5. It may be ensured that the cleaning activity in Ganga to be undertaken seriously . To oversee the activities undertaken by NMCG, either Chairman, CWC or member CWC or one JS level officer may be present.

6. A meeting of Chief Minister of Rajasthan and Haryana be called to resolve the matter of Water sharing of Renuka, Kishau and Lakhwar Vyasi Project and starting up of work.
