Minutes of 111th Weekly Review Meeting held under the Chairmanship of Secretary(WR, RD & GR) on 29.03.2017

The 111th Weekly Review Meeting was held on 29.03.2017 under the Chairmanship of Secretary(WR, RD & GR) in which matters of Expert Committee on Cauvery/Mahanadi, Flood forecasting, FMP, Online monitoring of key data of CWC and continuation of plan scheme beyond 12th plan were discussed in details. The following action points were identified for further action:

Continuation of On-going Schemes beyond 12th FYP

JS&FA made a power point presentation in the matter. He mentioned that in terms of MoF O.M. dated 23rd February, 2017 and 27th March, 2017, approval of Ministry/MoF would be required for the continuation of ongoing schemes beyond 12th plan. Each scheme is to be aligned with the Financial resource cycle of 14th Finance Commission ending by March, 2020. The proposal should have sunset date, outcome review, rationalization/integration with other continuing schemes etc. The detail of all such schemes to be provided to JS&FA for sending it to MoF/scrutiny at Ministry level.

 - f) DWRIS Shri H.S. Sanger, Director and Shri Masood Hussain, Member, RM(By 15th April, 2017)
 - g) Ground Water Management Chairman, CGWB (By 20th April, 2017)
 - h) River Management Activity in border areas Comm(FM)
 - i) HRD & CB/ID scheme JS(A)
 - j) Minor Irrigation census ADG(Stat)
 - k) R&D program JS(PP)
 - I) FBP Comm(FM)

Any scheme amongst the above mentioned schemes costing more than 500 crores needs to be submitted to JS(FA) before 07th April, 2017.

Flood Forecasting

Director, CWC made a presentation on progress of setting up various flood forecasting stations/Hydrological observation stations. Points emerged are as under:-

i. The Hydrological data on water available with various states and their actual entitlement is not clear especially of states like Rajasthan and Haryana etc. The disputed sites of states need to be listed. Therefore, a concept note is to be prepared covering all strategic points for HO sites, information required to be collected for dissemination and whether those HO sites selected should be able to provide the desired information.

ii. There is a need of an integrated plan including flood forecasting, NHP, DWRIS and FMP. All the information may be compiled and a presentation be made in the next weekly review meeting with complete data, statutory/mandatory provisions/policy focus areas etc. Critical sites where telemetry has not been planned and proposal for incorporation in future thereof be included in the presentation.
