Minutes of 96th Weekly Review Meeting held under the Chairmanship of OSD(WR, RD & GR) on 23.11.2016

The 96th Weekly Review Meeting was held on 23.11.2016 under the Chairmanship of OSD(WR, RD & GR) in which review of progress of Basin wise study of River Basins, action plan for India Water Week and Water Awards were deliberated in detail. The following action points were identified for further action :

- 1) JS&FA highlighted that the overall expenditure has been 68% excluding NMCG. However expenditure under the schemes DRIP, FBP, Flood Forecasting, River Management Activity in Border Areas and NHP has been not satisfactory. SMDs for these schemes may process their proposals to increase its expenditure as per budget. Letter should go to MoF for greater allocation at RE stage.

- 2) The guidelines for the Central Sector Scheme "River Management Activities in Border Areas" may be finalised on priority to expedite expenditure.

- 3) Advertisement of the EOI for selection of consultant for River Basin Studies may be issued in leading newspapers immediately.
- 4) In those River Basins where there is less progress, CWC may explore involving NIT/IIT or some other leading institution for the work.
- 5) A meeting of the Committee constituted for the study be called in the first week of December, 2016. It may be ensured at least one expert from IISC, Bangalore attend the meeting.
- 6) Thereafter CWC should prepare a proper road map along-with timelines of each of the activities for these studies.

- 7) NWDA should confirm with MEA whether Japan is willing to be a partner for India Water Week, 2017. File of India Water Week may be put up to Hon'ble Minister(WR, RD&GR) immediately.
