#### OFFICE MEMORANDUM

Subject:-Constitution of a Committee to address the issues of Water Management of Krishna Water between the State of Andhra Pradesh and Telangana State.

It has been decided with the approval of the Competent Authority to constitute a Committee to suggest a mechanism for facilitating the effective functioning of the Krishna River Management Board as per the provisions of the Andhra Pradesh Reorganisation Act, 2014. The composition of the Committee is as under:

- 1 Shri A D Mohile, Former Chairman, CWC
- 2 Shri M Gopala Krishnan, Former Member, CWC
- 3 Shri M.K. Goel, Scientist G, NIH, Roorkee
- 4 Shri N.N. Rai, Director (Hydrology), CWC
- 5 To be nominated from CPES from Ministry of Power

The committee can co-opt any other member as they deem appropriate.

## 2. FUNCTION/TERMS OF REFERENCE OF THE COMMITTEE:

The objective of Committee will be to suggest a mechanism for making the Krishna River Management Board discharge its function as per the provisions of the Andhra Pradesh Reorganisation Act, 2014 specifically addressing the following issues.

- (i) Preparation of Manual on Operating Rules/Procedures in respect of common projects located on river Krishna.
- (ii) Allocation of Godavari waters being transferred to Krishna Basin in accordance with Godavari Water Disputes Tribunal Award, 1980.

The Committee shall submit its Report/Manual etc. to Ministry of Water Resources, River Development and Ganga Rejuvenation, New Delhi with a period of 90 days.

# 3 SUPPORT AND INFORMATION TO THE COMMITTEE

- (i) Government of Andhra Pradesh and Telangana shall provide all necessary support and information to enable the Committee to complete its assigned task.
- (ii) All data required/as decided for the smooth functioning of the Committee from the respective members States shall be made available to the Committee as per format, frequency and mode of transmission as may be decided by the

Committee. In case of emergent situation all data/inputs as desired by the Committee may be made available by the member-State/CWC on urgent hasis.

The Committee may seek help from CWC and/or any other State/Central (iii) Agencies to undertake its assigned functions.

#### REMUNERATIONS 4.

- The Travel, Boarding, Lodging and other expenses shall be borne by Krishna River (i) Management Board;
- The non-official member(s) of the Committee, if they have retired from Govt. Service, (ii) will be paid TA/DA at the same rate as admissible to them at the time of retirement from Govt. Service. If otherwise, TA entitlement may be regulated as admissible to a Govt. official drawing Grade Pay of Rs. 6600/- (Sixth Pay Commission) as per M/o Finance OM No. 19030/3/2008-E. IV dated 23.09.2008.
- Sitting fee @ Rs. 2500/- (Rupees Two Thousand and Five Hundred only) per day of (iii) sitting fee to non-official member(s) will be paid.
- The secretariat support/Logistics shall be provided by Member Secretary, Krishna 5. River Management Board.
