Audit report of Web based System for Receipt and Processing of Applications for Issuing of NOC for Industry, Infrastructure, Mining and Domestic Purpose to Abstract Ground Water (CGWA-NOCAP)

Project Objective

CGWA-NOCAP - Web based Application for the Receipt and Processing of Applications for issuing of NOC to Abstract Ground Water is being developed to cater the need of CGWA. The online system would facilitate Issue of No Objection Certificate (NOC) for abstraction of ground water for various purposes like domestic, industrial, infrastructure and mining uses by CGWA in a transparent and efficient manner and hence reduce the time lag eliminating the existing manual process

In order to make the entire process more transparent and user friendly, this Web based System has been developed for Receipt and Processing of Applications for the issue of NOC to Abstract Ground Water. Through the user friendly interface, the user has been provided the facilities upload online application for NOC and to know the status of the application online with the help of Application Number allotted at the time of submission of the application and through SMS.

The application have following modules/ procedure :

- **Online Registration** of the Applicant
- **Online submission of application** requesting for Issuing of NOC for domestic, Industrial, Infrastructure and mining purpose and tracking of its status.
- **Save as draft** application facility for the applicant.
- **Offline submission** (entered by official) of application (domestic, Industrial, Infrastructure and mining) and tracking of its status.
- **Tracking** of Application status through SMS also.
- Generation of **Application Number** to end user for future reference.
- **Workflow** based application approval and NOC preparation and generation process between the CGWA officials.
- **Generation of NOC** in pdf format and signed by the Approving Authority (Officer) for issuing NOC.
- **Generation of letters** such as of Regret Letter, Exemption Letter in pdf format.
- Generation of **DLEC, Evaluation proforma, Check List**
- **Renewal** of Industry, Infrastructure application
- **Renewal of NOC**
- Provision to **upload signed document** (NOC, Letters etc.)
- Complete **Automation of Internal Workflow** of all the officials of CGWA at Head Quarters, Regional Offices and District Offices for application processing and NOC generation.
- **Dashboard**
- **Integration** with Cabinet Secretariat Portal as per directions of the Cabinet Secretariat on Strategy Plan for digitization of Services / Clearances relating to various Sectors in pursuance to Prime Minister Office Agenda of "Ease of Doing Business" in India and Digital Plan.
- **Location Directory** creation
- **Eligibility Criteria** application
- **Archival Data** application
- Coordination between district offices, eighteen regional offices of CGWB and CGWA office located at New Delhi will be easier, time effective and cost effective.

- Effective monitoring of processes and pending cases.
- Dissemination of information at different levels based on the role.
- The online system will not only bring transparency in the system but also guard against indiscriminate extraction of ground water.
- Email/ SMS/Application notifications based on different rules.
- Alerts for CGWA officers through Email/SMS/Application Inbox.


The NOCAP software has been developed using the Microsoft Technology and database. The following are the technical details :

The application has been hosted on NIC Cloud data centre. The application has been security audited for all the latest vulnerabilities. Application backup for front end and database is regularly taken.




The architecture for this system is given bellow.




Application Architectural Design





Conclusion :

The application has been made very user friendly and easy to operate/ navigate. But this is not completely paperless. Applicant still has to submit the hardcopy of the application along with the required documents as per the CGWA guidelines. It is observed that many application (around 66 applications) were classified as **"verification not completed"** because of the none receipt of papers.

The following provisions may be incorporated in the application :

1. The uploading of digitally signed documents may be available
2. Till all the forms and documents are not completed application should be considered as draft only.
3. Application should have in-built checks that applicant have completed the application.
