The third meeting of the Apex Committee on the Digital India Programme was held on 15th October 2015 under the Chairmanship of Shri P.K. Sinha, Cabinet Secretary, Government of India. The list of participants is at **Annexure 1**.

- 2. Secretary, DeitY made a presentation on the agenda items. The presentation is placed at Annexure 2.
- Agenda 1: Action Taken Report

The Action Taken Report was taken note of and the following decisions were taken in that regard.

- a. e-Prison M/o Home Affairs has taken the ownership of e-Prison. Joint Secretary, MHA informed that CCEA note has been moved for extension of CCTNS and integration of e-Prisons, CCTNS and e-Courts across India.
- b. Khoyapaya Portal The Portal has been launched. Further as per Supreme Court directive, it is being integrated with Track the missing child portal.
- c. National Scholarship Portal On-boarding of National Scholarship Portal to be accelerated by M/o Social Justice & Empowerment (SJE), MHRD, M/o Minority Affairs and M/o Tribal Affairs. M/o SJE may take ownership of the Portal [Action M/o SJE, MHRD, M/o MA, M/o TA]

d. e-Basta – Additional Secretary, D/o Higher Education informed the Committee that the Department would examine the possibility of taking ownership of the Portal. It was felt that in case MHRD did not wish to take ownership, DeitY may choose to operate the portal themselves with an appropriate business model.

[Action - MHRD and DeitY]

e. **Mission Mode Project (MMP) Implementation** – It was decided that Ministries / Departments concerned, as indicated in the table below, may take action to ensure that necessary approval of MMPs by the Competent Authority is obtained by 31.12.2015 and implementation is initiated latest by 31.03.2016.

f. Gl Cloud (Meghraj) -

(i) Technical support for implementation of GI Cloud applications should be provided by NIC in Ministries/Departments.

- (ii) It was recommended that the Policy for utilisation of private cloud service providers and floating of RFP for empanelment of the same may be formulated by 31st December 2015. [Action DeitY]
- g. e-Books The Apex Committee recommended that Service Books of Public Servants may be redesigned, upgraded, and converted into e-service books. [Action DoPT]

4. Agenda 2: Digital Locker

- a. Secretary DeitY explained the concept of Digital Locker. He requested that D/o Revenue may consider linking PAN with Digital Locker. Secretary D/o Revenue requested for a presentation on Digital Locker where CBDT officials would also be invited. [Action DeitY]
- b. It was recommended that Departments may integrate with Digital Locker in a time bound manner. To begin with, on-boarding may be initiated by Department of School Education & Literacy (for CBSE, NIOS & State Educational Boards), Department of Higher Education for IITs/IIITs/Central Universities & AICTE recognized Colleges and UGC recognized State Universities / Colleges, Department of Pensions for PPOs. Department of Revenue may examine the possibility of integrating PAN Data with Digital Locker. DeitY, in coordination with D/o Land Resources, may take up with State Governments, the integration of property registration with Digital Locker within the next 3 months. DeitY would extend technical support to all Ministries / Departments for integration with Digital Locker. [Action—D/o SE&L, D/o HE, D/o P&PW, D/o Revenue, D/o Land Resources and DeitY]

5. Agenda 3: e-Hospital –

(i) Secretary, M/o H&FW informed about the plan of developing a common health platform with the standards as adopted by M/o H&FW to integrate the existing systems and deliver citizen services.

(ii) It was recommended that M/o H&FW may bring all Central Government hospitals on-board the e-Hospital application in a time bound manner. Further, M/o H&FW may also suggest to States/UTs to utilize the e-Hospital application.

[Action-D/o H&FW]

(iii) It was also recommended that the e-Hospital application should focus on creating more facilities for citizens in addition to automation of the organization's internal processes. For instance, besides the appointment management system, it may be examined whether health records can be brought online for access by patients/doctors. Also, whether health advisories and tips can be sought on line.

[Action - Deity]

- .6. Agenda 4: All Government payments & receipts to be online -
 - There was general consensus that all government payments should be made electronic as soon as possible. All forms of payment should be considered including PayGov, RTGS, NEFT, Mobile Payment, Wallet, etc.
 - ii. It was recommended that all Ministries / Departments may provide for electronic payment system for all payments and receipts by 31st March 2016 and make at least 90% of all payments & receipts online by 31st December 2016. DeitY may facilitate integration with PayGov. [Action All Ministries / Departments]
- 7. Agenda 5: Model Request for Proposal (RFP) for e-Governance projects It was recommended that DeitY may send the draft model RFP for e-Governance by 30th November 2015 for it to be vetted by D/o Expenditure. The RFP may borrow best practices from other Departments. [Action DeitY, D/o Expenditure]
- 8. Agenda 6: Government Process Re-engineering (GPR) using Single Source of Truth (SSOT) The concept and roadmap of Government Process Re-engineering using Single Source of Truth was recommended by the Apex Committee. It was also recommended

that DeitY would work with the concerned Ministries to identify domain ownership of different datasets and its metadata standards for implementing the concept of GPR using Single Source of Truth by 31st March 2016. [Action – DeitY]

- 9. Agenda 7: Jeevan Pramaan It was recommended that D/o Financial Services may work for voluntary seeding of Aadhaar in bank accounts of pensioners. The banks may be asked to use Banking Correspondents and also to tie up with Common Service Centres (CSCs) for Aadhaar enrolment. As informed by DeitY, the possibility of using smart / feature phones having IRIS scanning cameras for biometric authentication may also be explored. [Action–DFS, DeitY]
 - 10. Agenda 8: Preference for Domestically Manufactured Electronic Goods (PMA) Ministry of Health &Family Welfare informed that the work related to medical devices is being dealt with by D/o Pharmaceuticals. It was recommended that D/o Pharmaceuticals may take immediate steps to notify medical electronic products under the PMA policy. [Action D/o Pharmaceuticals]
 - 11. **Agenda 10: Implementation of Open Data Policy** It was recommended that Departments concerned may publish their datasets, subject to disclosure policy as applicable, on the Open Data Platform. **[Action– All Ministries / Departments]**
 - 12. Digital India Progress:
 - a. Special Secretary, DoT informed about the latest status of Bharat Net implementation. The present implementation arrangement is being continued for about 1 lakh Gram Panchayats and it is likely to be completed by December 2016. New implementation strategy and arrangements are being worked out for the remaining Gram Panchayats, which are expected to be completed by December 2017. It was informed that alternative connectivity models are also being examined in the Department so as to cover all the GPs quickly. It

- was recommended that all Departments may also focus on utilization of the infrastructure being created. [Action: DoT and all MMP Departments]
- 13. Joint Secretary, D/o Financial Services stated that Post Offices would start offering online financial services and would require connectivity of 2 Mbps for going digital and requested that DoT may explore the options for providing connectivity for this.[Action: DoT]
- 14a. It was recommended that DeitY should closely monitor the progress of MMPs and bring exception reports and Inter Ministerial issues for deliberation in future meetings of the Apex Committee.
- 14b DeitY may focus on important Digital India projects that may lead to quick fruition.
- 14c. DeitY may draw up specific timelines for each of the components of Digital India so that progress may be reviewed against them in future meetings of the Apex Committee. [Action: All Departments and DeitY]
- 15. The meeting ended with the vote of thanks to the chair.
