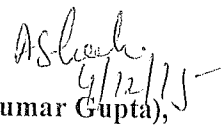

Please refer to my D.O. letters No.55/23/2015-P&PW(C) dated 22nd September, 2015 and No. 5/39/2015-P&PW(C) dated 28th October, 2015 regarding launch of an online system for tracking pension sanction and payment process 'Bhavishya'.

2.
