Subject:- Gov.in Domain registration process for the websites /webpages – reg.

The undersigned is directed to refer to the minutes of the 14th review meeting held on 10.09.2015 under the Chairmanship of Joint Secretary (A) for discussing e-Governance issues and to say that it is necessary to acquire gov.in domain for the new Webpages/websites launched for the regional Offices.

2. In this matter, there is a process prescribed by Department of Electronics & IT (DeitY), which is needed to be followed for acquiring the Gov.in domain name. The details may be accessed at <https://registry.gov.in>. The users are required to register their domain. On successful registration of their domain, the authorization letter in the prescribed format would be emailed to the users.

3. As per the requirement of DeitY, the duly filled authorization letter (by the Head of the Organization) is required to be forwarded by the Joint Secretary of the Parent Ministry. In view of this, it is requested to follow the prescribed guidelines and to furnish the duly filled authorization letter to the Ministry for taking further necessary action.
