The undersigned is directed to refer to this Section's OM of even no. dated 26.02.2016 regarding taking necessary action for providing CCMS data to LIMBS Portal.


2. In this connection it is stated that another D.O. No. A-60011/14/2014-Admn.IV(LA) dated 01.03.2016 has been received from Shri Suresh Chandra, JS & LA, D/o LA on the above mentioned subject stating that the LIMBS application will host huge data, involve various stake holders, Nodal Authorities to take data driven decisions, know the date of hearing in advance and may enable the authorities to prepare their response in advance. It has further been mentioned that this Ministry is following more or less similar application namely Court Case Monitoring System (CCMS) for monitoring of all ongoing court cases.

3. In order to avoid duplication of data, efforts and saving manhours, JS & LA requested to allow NIC and LIMBS implementation Team for porting data available in CCMS into LIMBS, so that complete data about court cases be available at one place.

4. In this regard, a decision has been taken for porting data into LIMBS portal from CCMS which may invariably be completed within 15 days of receipt of this OM. The copy of D.O. letter dated 01.03.2016 is enclosed herewith for ready reference.
