Subject: Minutes of the Review Meeting of Parliament Assurances taken by Additional Secretary, M/o WR, RD & GR on 03.08.2015.

The Review Meeting of Parliament Assurances was held on 03.08.2015 under the Chairpersonship of Additional Secretary. Current status of the fulfilment of Assurances (Annexure) and the reason for delay in fulfilment of Assurances were discussed at length. Following action points were identified for further action:-

1. JS & MD, NMCG informed that in most of the Assurances, part fulfilment report (interim reply) will be sent within 30.08.2015.

[Action: JS & MD, NMCG]

2. Commissioner (FM) informed that information from some of the State Governments and Ministry of Environment, Forest and Climate Change is awaited. It was decided that Commissioner (FM) will speak to State Governments and Ministry of Environment, Forest and Climate Change for expediting the information. It was also decided that FM Division will review all the Assurances and transfer those Assurances which are related to Ganga to NMCG.

[Action: Commissioner (FM)]

3. Commissioner (BB) informed that information from certain State Governments is awaited. It was decided that Commissioner (BB) will contact officers from the State Governments for expediting the information.

[Action: Commissioner (BB)]

4. Director (PP) informed that English version of implementation report has already been approved by Hon'ble Minister for Water Resources, River Development and Ganga Rejuvenation. Hindi translation of implementation report is being done and will be sent to the committee on Government Assurances within 15 days.

[Action: Director (PP)]

5. Comm (Pen~~u~~ River) informed that information from CWC is awaited. It was decided that CWC may be asked to expedite the information.

[Action: Commissioner (PR)]

6. Other divisions were asked to take immediate action for fulfilment of all the pending assurances in their division.

[Action: All Concerned Divisions]

7. Parliament (Div) to also ensure upto date reconciling and convene another meeting in 2-3 weeks to review the pending assurances.

[Action: Dir (Parl)]

8. All divisions will invariably send a copy of letter sent to committee on Government Assurances requesting for extension of time, dropping of Assurances or fulfilment report to Parliament Section, so that upto date reports are available with Parliament Section.

[Action: All SMDs/Dir(Parl)]
