ORDER

Subject: Deputation abroad of Shri Ajay Kumar, Superintending Engineer, HOC, Noida, CWC for attending the Training Course on 'Morphological Modelling Using Delft 3D' to be organized by UNESCO-IHE, Delft, Netherlands during 18-22 September 2017 (excluding travel time).

Sanction of the Competent Authority in Ministry of Water Resources, River Development and Ganga Rejuvenation is hereby accorded for visit of Shri Ajay Kumar, Superintending Engineer, HOC, Noida, CWC for attending the Training Course on 'Morphological Modelling Using Delft 3D' to be organized by UNESCO-IHE, Delft, Netherlands during 18-22 September 2017 (excluding travel time).

2. The above mentioned officer is sanctioned the following:

- (i) **Air Travel:** As per entitlement
- (ii) **Tuition Fee:** Euro 950 to be paid to UNESCO-IHE, Delft, Netherlands
- (iii) **Student Accommodation:** Euro 270 (@ Euro 45 per night X 6 days)
- (iv) **Daily Allowance:** US\$600 (US\$ 100 per day for 6 days). Officer may withdraw DA either from Cash Section, CWC or from Indian Embassy in Netherlands
- (v) **Study related cost:** Euro 30 to be paid to UNESCO-IHE, Delft, Netherlands subject to availability of study material
- (vi) **Internal travel:** To be provided by Indian Mission in the Netherlands and if not arranged by the Indian Mission, admissible components of internal travel in the Netherlands may be reimbursed on production of actual bills.

3. The above expenditure shall be charged under chargeable head: 2701 M&MI, 80.003.04 HRD/ Capacity Building, 04.01 NWA, 04.01.12 FTA (Scheme) for the year 2017-18.

4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.

5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.

6. The official shall travel on official passports and submit a report about the visit to Ministry of External Affairs (Europe West Division) and Ministry of Water Resources, RD&GR within one month of their return to India.
7. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
8. This sanction issues with concurrence of IFD of the Ministry as conveyed vide their Diary No. 139/2017-IFD dated 05.09.2017.
