**ORDER**

**Subject: Visit of Dr. Amarjit Singh, Secretary (WR, RD & GR) to Israel for joining the Inter-Ministerial delegation, as a member, led by Hon'ble MoS (MEA) during 10<sup>th</sup>-12<sup>th</sup> May 2017 (excluding travel time).**

Sanction of the competent authority in Ministry of Water Resources, River Development & Ganga Rejuvenation is hereby accorded to the deputation of Dr. Amarjit Singh, Secretary (WR, RD & GR) for joining the Inter-Ministerial delegation, as a member, led by Hon'ble MoS (MEA) during 10<sup>th</sup>-12<sup>th</sup> May 2017 (excluding travel time), in Israel.

2. Dr. Amarjit Singh, Secretary (WR, RD & GR) is sanctioned the following:-

- (i) **Air Passage:** As per entitlement.
- (ii) **Daily Allowance:** US \$ 300 (@ US\$ 75 per day for 4 days). Secretary (WR, RD & GR) can draw the DA either in India (MoWR,RD&GR) or from Indian Mission in Israel.
- (iii) **Conveyance:** Internal travel is to be arranged by Indian Mission in Israel. If the Mission is unable to make arrangements, hiring of car is allowed.
- (iv) **Hotel Accommodation:** As per entitlement, to be arranged by Indian Missions at Israel/Istanbul, Turkey.
- (v) **Airport tax/health insurance:** As per actual.
- (vi) **Mobile phone:** To be arranged by Indian Mission and raise bills as per MoF Circular No. 24(1)/E.Coord./2010 dated 21.7.2010.

3. The officer shall travel on diplomatic passport.

4. The entire expenditure on the visit of Secretary (WR, RD & GR) shall be charged to Demand No.98, Major Head No. 3451.00.090.16.01.12-Secretariat Economic Services-Secretariat-Ministry of Water Resources-Foreign Travel Expenses of the Ministry of Water Resources, RD&GR for the year 2017-18.

5. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of Secretary (WR,RD&GR) will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.

7. The return journey of Secretary (WR, RD & GR) on 13.5.2017 is such that, as there is no other connecting AI flight from Istanbul during the day, he may be required to stay in Istanbul for more than 10 hours (forced halt) for which hotel accommodation and transport may be provided to him.

8. Secretary (WR, RD & GR) shall submit a report about his visit to Ministry of External Affairs (WANA Division) and Ministry of Water Resources (EA & IC Division) within one month of his return to India.

9. This issues with the approval of Screening Committee of Secretaries *vide* Ministry of Finance (Exp) ID Note No. 450300 dated 28.04.2017 and with the concurrence of IFD of MoWR, RD & GR *vide* their Diary No. 19/2017-IFD dated 05.05.2017 .
