ORDER

Subject: Deputation abroad of six officers of MoWR/ CWC to Denver, USA during 05-16 June 2017 (excluding travel time).

Sanction of the Competent Authority in Ministry of Water Resources, River Development and Ganga Rejuvenation is hereby accorded for visit of following six officers to attend International Training Program on Safety Evaluation of Existing Dams (SEED), conducted by United States Bureau of Reclamation (USBR), to be held during 05-16 June 2017 (excluding travel time) in Denver, USA:

- 1) Sh. Virender Sharma, SJC (BM), MoWR, RD & GR
- 2) Sh. Pramod Narayan, Project Director (DRIP) & Director (DSR), CWC
- 3) Dr. R K Gupta, Chief Engineer, Design (E&NE), CWC
- 4) Sh. O P Gupta, Director, FE&SA Directorate, CWC
- 5) Sh. Mayank Singh Chetan, Deputy Director (DSR) Directorate
- 6) Sh. Bikram Kesharee Patra, Assistant Director (DSR) Directorate

2. The above mentioned six officers are sanctioned the following:

- (i) **Air Travel:** As per entitlement
- (ii) **Cost of Training (including registration fees, site visit etc.):** \$US 24,180 (@ \$US4030 per head) – to be paid to USBR
- (iii) **Hotel Accommodation:** \$US 6000 (@ \$200 per day per head for 5 days) *
- (iv) **Daily Allowance:** US \$1260 (@90% of US \$100 per day per head for 14 days)

* (Hotel Accommodation in Denver, USA would only be availed if cheaper hotel accommodation is not available and certificate to the effect would be obtained from USBR, Denver, USA.)

3. The above expenditure in respect of above 6 officers shall be charged to CWC's Major Head: 2701 M&MI, 80.General, 80.800.17, Dam Rehabilitation and Improvement Project, 17.01.12 FTE for the financial year 2017-18.

4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.


5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.

6. The official shall travel on official passports and submit a report about the visit to Ministry of External Affairs (AMS Division) and Ministry of Water Resources, RD&GR within one month of their return to India.
7. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
