

ORDER

The sanction of the competent authority is hereby accorded to the deputation of Shri Ashok Kumar Jeph, Deputy Commissioner (B&B) to Knowledge Co-Creation Program on "Adaptive Watershed Management to Climate Changes: Flood Control and Ecosystem Conservation" to be held in Japan from 26 Jun'2017 to 26 Aug'2017 (excluding travel time) under the Technical Cooperation Program of Govt. of Japan.


2. The course covers the cost of a round-trip air ticket, travel insurance, allowances for accommodation, living expenses and others. All expenditures will be borne by Japan International Cooperation Agency.
3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the official will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O. M. No. 19036/7/75-E.IV (B) dated 5.8.76.
4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The official will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
5. The official shall travel on official passport and shall submit a report of the training to the Ministry of External Affairs and the Ministry of Water Resources, RD&GR within one month of his return to India.
6. Remuneration/honorarium, if any, received by the officer during the visit will be governed by SR-11 and SR-12 (FR-SR, Part-I) and Govt. of India orders.
