ORDER

Subject: Visit of Shri U.P. Singh Director General, NMCG and Shri Hitesh Kumar S Makwana, Executive Director (P), NMCG to London UK during 27-29 November 2017 (excluding travel time) for organizing road show in connection with Namami Gange Project.

Sanction of the competent authority is hereby accorded to the deputation of Shri U.P. Singh, Director General, National Mission for Clean Ganga and Shri Hitesh Kumar S Makwana, Executive Director (P), NMCG to London, UK for organizing road show in connection with Namami Gange Project during 27-29 November 2017 (excluding travel time).

2. Each of the two officers is sanctioned the following:-

- (i) **Air Passage (to and fro):** As per entitlement.
- (ii) **Daily Allowance:** US \$ 400 (@ US\$ 100 per day for 4 days) for each officer. Officers can draw the DA either in India or from Indian Mission in UK. In case, meals are included in hotel accommodation, the DA will be given at reduced rates as per GoI guidelines.
- (iii) **Conveyance:** Internal travel is to be arranged by Indian Mission in UK. If the Indian Embassy/ Mission does not provide official vehicles for local travel the officers may avail of local taxi services for local official trips (reimbursable on production of receipt), wherever available.
- (iv) **Hotel Accommodation:** As per entitlement, to be arranged by Indian Mission in UK.
- (v) **Airport tax/health insurance:** As per actual.

The expenses on the above visit shall be charged on NMCG's Financial Head 3435.04.101.06.03.12 Non-EAP, NGRBA for the year 2017-18.


3. The officers shall travel on diplomatic/ official passport. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.

5. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.

6. The officer shall submit a report about his visit to Ministry of External Affairs (Europe West Division) and Ministry of Water Resources (EA & IC Division) within one month of their return to India.


7. This issues with the approval of Screening Committee of Secretaries *vide* Ministry of Finance (Dept. of Exp) ID Note No.DC-300360957/E.Coord-2017 dated 25.11.2017 and with the concurrence of IFD of MoWR, RD& GR *vide* their Diary No. 260/2017 -IFD dated 24.11.2017.
