

ORDER

 4. The period of absence from India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the provisions of Para. 13-15 of Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
 5. The resignation or request for voluntary retirement from service while abroad in respect of the officer will not be entertained under any circumstances. The officers shall not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
 6. The officers may submit a report about the visit to Ministry of External Affairs and Ministry of Water Resources, RD&GR within one month of their return to India.
