**ORDER**

**Subject: Visit of 12 members of CWC, CGWB and NIH of MoWR, RD & GR and NRSC (ISRO) to the Netherlands for attending Water Accounting Plus (WA+) training to be held during 12<sup>th</sup> March - 8<sup>th</sup> June, 2018 (excluding journey time) at IHE, Delft, the Netherlands.**

In supersession of this Ministry's sanction order of even number dated 27.2.2018 on the subject cited above, the competent authority in Ministry of Water Resources, River Development & Ganga Rejuvenation has rescheduled the date of the visit of following twelve officers of CWC, CGWB, NIH and NRSC (ISRO) to Netherlands for attending "Water Accounting Plus" training at IHE, Delft, the Netherlands from 5<sup>th</sup> March – 1<sup>st</sup> June 2018 to 12<sup>th</sup> March - 8<sup>th</sup> June, 2018 (excluding travel time).

2. The above mentioned officials are sanctioned the following:
- i. **Training Cost:** (Tuition fee, study related cost, health insurance, boarding and lodging, local transport and to & fro airfare) - Euro € 2,08,407/- for (12) twelve participants payable to Delft, the Netherlands.
  - ii. **Daily allowance:** Euro 885.75 per person for three months (i.e. 25% of Euro 1181 per month).
3. The above expenditure in respect of the officials shall be charged as under:-
- i. **For Training cost:** An advance of 40% of total training cost i.e. Euro € 2,08,407/- to be paid to IHE, Delft, the Netherlands from the Head - 2701.80.004.08.01.20 OAE External and 2701.80.004.08.02.20 OAE Domestic (50% from each head) for the year 2017-18, and 25% of the payment of the total training cost is to be released before the start of the programme at NWA, Pune and the remaining 35% of the payment is to be released within 30 days of the completion of the programme from the same head for year 2018-19.

- ii. **DA:** To be paid from the Head-2701.80.004.08.01.12 FTE External and 2701.80.004.08.02.12 FTE Domestic (50% from each head) for the year 2017-18 (DA can be drawn either in India (MoWR) or from Indian Embassy in the Netherlands).
4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
5. The officials concerned will submit a report on completion of training to EA&IC, MoWR, RD & GR and Ministry of External Affairs, within one month of their return.
6. This sanction issues with the concurrence of IFD of the Ministry *vide* their diary No. 373/2017-IFD dated 5.3.2018.


