ORDER

Subject: Visit of Dr. C. V. Dharma Rao, Adviser, National Water Mission to attend the side event in Katowice, Poland during CoP-24 to be held on 12th December, 2018 (excluding travel time).

Sanction of the competent authority in Ministry of Water Resources, River Development & Ganga Rejuvenation is hereby accorded to the deputation of Dr C. V. Dharma Rao, Adviser, National Water Mission to attend the side event on "Water Resources Conservation and Management for climate resilient development" being hosted by MoWR,RD&GR and to be held on 12th December, 2018 (excluding travel time) at Katowice, Poland.

2. The above officer has been sanctioned the following:-

- i. **Air Passage:** As per entitlement.
- ii. **Daily Allowance:** US \$ 150 (@ US\$ 75 per day for 2 days). The officer may draw the DA either in India (MoWR,RD&GR) or from Indian Embassy in the Poland.
- iii. **Conveyance:** Internal travel is to be arranged by Indian Embassy in the Poland. If the Embassy is unable to make arrangements, taxi services may be availed for local trips (to be reimbursed on production of actual bills, wherever applicable).
- iv. **Hotel Accommodation:** As per entitlement, to be arranged by Indian Embassy at the Poland.
- v. **Airport tax/health insurance/ visa fees:** As per actual.
- vi. **Mobile phone:** To be arranged by Indian Mission and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.

3. The expenditure on the above visit will be booked under NWM Major Head FTE (Foreign Travel Expenses) 2701.80.004.11.04.12 for the year 2018-19. No additional funds would be sought from MoWR, RD&GR on this account under FTE/Grants by the organization concerned.

4. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

5. The officer shall travel on official/ diplomatic passport.

6. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.


7. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.

8. The officer shall submit a report about his visit to Ministry of External Affairs (Central Europe Division) and Ministry of Water Resources (EA & IC Division) within one month of his return to India.
