ORDER

Subject: Deputation of two officials from MoWR, RD & GR to attend 11th Hindi Vishwa Samelan programme to be held from 18-20 August 2018 in Mauritius.

Sanction of the President is hereby accorded to the deputation of following two officials from MoWR, RD & GR to attend 11th Hindi Vishwa Samelan programme to be held from 18-20 August 2018 in Mauritius (excluding travel time):

- (i) Smt. Veena Satyawadi, Assistant Director (OL), MoWR, RD & GR
- (ii) Shri Paramjit Yadav, Sr. Translator, MoWR, RD & GR

2 Each member of the delegation is sanctioned the following:

- (i) Air passage: As per entitlement
- (ii) Daily Allowance: USD 240 for 4 days per person (@ USD 60 per head per day for 4 days). Daily Allowance can either be drawn in India or from Indian Embassy in Mauritius.
- (iii) Hotel Accommodation: As per entitlement for 4 days (to be arranged by Indian High Commission in Mauritius and raise the bills as per rules)
- (iv) Internal Conveyance: To be arranged by MEA.
- (v) Airport tax/ health insurance: As per actuals.

3. All the above officers shall travel on official passport.

4. The expenditure on the visit may be charged to Grant No.97, Major Head No.3451.00.090--16.01.12 – Secretariat Economic Services-Secretariat-Ministry of Water Resources-Foreign Travel Expenses of the Ministry of Water Resources for the year 2018-2019.

5. The period of absence from India and grant of pay and allowances and counting of services for increment of the officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.76.

6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.


