ORDER

Subject: Deputation abroad of two officers from National Mission for Clean Ganga to participate in "Outreach in UK for better engagement for Ganga" Program in London, England and Scotland from 12th-13th July, 2018 (excluding travel time).

Sanction of the competent authority is hereby accorded to the deputation of Shri Rajiv Ranjan Mishra, Director General, NMCG and Shri Rozy Agarwal, Executive Director (Finance), NMCG for participating in "Outreach in UK for better engagement for Ganga" Program in London, UK and Scotland from 12th-13th July, 2018 (excluding travel time)

2. The above officers mentioned above are sanctioned the following:-


- i. **Air Passage:** As per entitlement.
- ii. **Daily Allowance:-** US\$ 300 (@US\$ 100 per day per head for 3 days). DA can be drawn either in India (MoWR) or from Indian High Commission in UK. (DA at reduced rates may be given if meals are provided/ included in hotel)
- iii. **Conveyance:** Internal travel is to be arranged by Indian High Commission in UK. If the Indian Embassy/Mission does not provide official vehicle(s) during the visit, the delegation is allowed to avail taxi services for official trips, (reimbursable on production of receipt wherever available).
- iv. **Hotel Accommodation:** As per entitlement, to be arranged by Indian High Commission in UK
- v. **Airport tax/health insurance/visa charges:** As per actual.
- vi. **Mobile phone:** To be arranged by Indian High Commission and raise bills as per MoF Circular No. 24(1)/E.Coord./2010 dated 21.7.2010.

3. The officers shall travel on diplomatic/official passports.

4. The expenditure on the visit may be charged to Grant No.97, Major Head No.3451.00.090.16.01.12-Secretariat Economic Services-Secretariat-Ministry of Water Resources-Foreign Travel Expenses of the Ministry of Water Resources for the year 2018-2019.

5. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of the officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.
