ORDER

Subject: Visit of Shri Sundeep, Director (T-II), NMCG, to attend ACCADUEO (exhibition) from 17th to 19th October, 2018 (excluding travel time) at Bologona, Italy.

Sanction of the competent authority in Ministry of Water Resources, River Development & Ganga Rejuvenation is hereby accorded to the deputation of Shri Sundeep, Director (T-II), National Mission for Clean Ganga, to attend ACCADUEO (exhibition) from 17th to 19th October, 2018 (excluding travel time) at Bologona, Italy.

2. The above officer has been sanctioned the following:-

- (i) **Air Passage:** As per entitlement; Air fare up Euro 500 will be provided by the organizers of the event and the bill for the excess fare will be raised by the organizers to NMCG.
- (ii) **Daily Allowance:** US \$ 300 (@ US\$ 100 per day for 3 days). The officer may draw the DA either in India (MoWR, RD&GR) or from Indian Mission in the Italy.
- (iii) **Conveyance:** Internal travel is to be arranged by Indian Mission in the Italy. If the Mission is unable to make arrangements, taxi services may be availed for local trips (to be reimbursed on production of actual bill, wherever applicable).
- (iv) **Airport tax/health insurance/ visa fees:** As per actual.

3. The expenditure on the above visit shall be borne by NMCG. No additional funds would be sought from MoWR, RD&GR on this account under FTE/Grants by the organization concerned.


4. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

5. The officer shall travel on official/ diplomatic passport.

6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.

7. The officer shall submit a report about his visit to Ministry of External Affairs (Europe West Division) and Ministry of Water Resources (EA & IC Division) within one month of his return to India.
