
2. The above officers are sanctioned the following:-

- (i) **Air Passage:** As per entitlement.
- (ii) **Daily Allowance:-** US\$ 225 for 3 days (@US\$ 75 per day per head in respect of officers mentioned at sl.no.1&2) and US\$ 450 for 6 days @US\$ 75 per day per head in respect of officers mentioned at sl.no.3&4. DA can be drawn either in India (MoWR) or from Indian Embassy in Brazil.
- (iii) **Conveyance:** Internal travel is to be arranged by Indian Mission in Brazil. If the Embassy is unable to make arrangements, hiring of car is allowed.
- (iv) **Hotel Accommodation:** As per entitlement, to be arranged by Indian Embassy in Brazil.
- (v) **Airport tax/health insurance:** As per actual.
- (vi) **Mobile phone:** to be arranged by Indian Embassy in Brazil and raise bills as per MoF Circular No. 24(1)/E.Coord./2010 dated 21.7.2010.
- (vii) **Contingency:** Rs. 600/- [@ Rs. 200/- per day for 3 days] [For Hon'ble Minister OF State (WR,RD&GR) only].

4. The entire expenditure on the visit of the officer mentioned above may be charged to Grant No. 98, Major Head No. 3451.00.090.16.01.12–Secretariat Economic Services–Secretariat–Ministry of Water Resources–Foreign Travel Expenses of the Ministry of Water Resources, RD&GR for the year 2017-18.

The period of absence from the post in India and grant of pay and allowances and counting of services for increment of the two officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-EIV (B) dated 5.8.1976.
6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.
7. A report about this visit may be submitted by the officers to Ministry of External Affairs (LAC Division) and Ministry of Water Resources (EA Division) within one month of his return to India.


