The period of absence from the post in India and grant of pay and allowances and counting of increment for the official will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 5.8.1976. The grant of CCA will be regulated in accordance with the provisions of that Ministry's O.M. No.2/3/E.II dated 27.11.1965 as amended from time to time.
4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
6. The officials shall travel on personal/official passports and shall submit a tour report to Ministry of External Affairs (East Asia Division) and the Ministry of Water Resources (EA & IC Desk) within one month of their return to India.
7. This sanction order issues with the concurrence of Integrated Finance Division of Ministry of Water Resources vide their Diary No. 313/IFD/2018 dated 19.01.2018.
