ORDER

Subject: Visit of 4 member delegation to participate in the European Water Week, September 24-27, 2018 (excluding travel time) at Leeuwarden, the Netherlands.

Sanction of the competent authority in Ministry of Water Resources, River Development & Ganga Rejuvenation is hereby accorded to the deputation of following 4 officers to participate in the European Water Week, September 24-27, 2018 (excluding travel time) at Leeuwarden, the Netherlands:

- a) Mr. M.K.Srinivas , Director General, National Water Development Agency
- b) Mr. Amrendra Kumar Singh, Chief Engineer, Central Water Commission
- c) Mr. Amlanjyoti Kar, Superintending Hydro geologist, Central Ground Water Board
- d) Mr. Mukesh Kumar, Under Secretary (EA&IC), MoWR, RD &GR.


2. Each of the above officer is sanctioned the following:-

- (i) **Registration Fees:** Euro 400+VAT (@ Euro 350+VAT for 24-26 September 2018 and Euro 50+VAT for 27 September 2018) to be arranged by Indian Mission in the Netherlands. In case, the Mission is unable to make arrangements for the registration fees, the officers may pay registration fees themselves which will be reimbursable to the officers, on production of receipts/ bills.
- (ii) **Air Passage:** As per entitlement.
- (iii) **Daily Allowance:** US\$ 500(@ US\$ 100 per day for 5 days). The officers can draw the DA either in India (MoWR,RD&GR) or from Indian Mission in the Netherlands.
- (iv) **Conveyance:** Internal travel is to be arranged by Indian Mission in the Netherlands. If the Mission is unable to make arrangements, taxi services may be availed for local trips (to be reimbursed on production of bill, wherever applicable).
- (v) **Hotel Accommodation:** As per entitlement, to be arranged by Indian Mission at the Netherlands.
- (vi) **Airport tax/health insurance:** As per actual.
- (vii) **Mobile phone:** To be arranged by Indian Mission and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.

3. The officer shall travel on official/ diplomatic passport.

4. The entire expenditure in respect of the visit of above officers shall be borne under FTE Budget Head/ Grants for the year 2018-19 of their respective organizations i.e. National Water Development Agency, Central Water Commission, Central Ground Water Board and Ministry of Water Resources, RD & GR respectively. No additional funds would be sought from MoWR, RD&GR on this account under FTE/Grants by the organizations concerned.

5. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
