ORDER

Subject: Deputation of Shri Sanjay Kundu, Joint Secretary, MoWR, RD&GR to Paris,(France) on 27-28 February, 2018 (excluding travel time).

Sanction of the competent authority in Ministry of Water Resources, River Development & Ganga Rejuvenation is hereby accorded to the deputation of **Shri Sanjay Kundu, Joint Secretary, MoWR, RD&GR to Paris** (France) to attend 2nd Preparatory meeting of the Political Process of the 8th World Water Forum scheduled to be held at the UNESCO HQ in Paris (France) during 27-28 February, 2018 (excluding travel time).

2. Shri Sanjay Kundu, Joint Secretary (RD &PP) is sanctioned the following:-

- (i) **Air Passage:** As per entitlement.
- (ii) **Daily Allowance:-** US\$ 300 for 3 days (@US\$ 100 per day per head) DA can be drawn either in India (MoWR) or from Indian Mission in Paris.
- (iii) **Conveyance:** Internal travel is to be arranged by Indian Mission in Paris. If the Mission is unable to make arrangements, hiring of car is allowed.
- (iv) **Hotel Accommodation:** As per entitlement, to be arranged by Indian Mission in Paris.
- (v) **Airport tax/health insurance:** As per actual.
- (vi) **Mobile phone:** to be arranged by Indian Mission in Paris and raise bills as per MoF Circular No. 24(1)/E.Coord./2010 dated 21.7.2010.

3. The officers shall travel on official/diplomatic passport.

4. The entire expenditure on the visit of the officer mentioned above may be charged to Grant No. 107, Major Head No. 3451.00.090.16.01.12–Secretariat Economic Services–Secretariat–Ministry of Water Resources–Foreign Travel Expenses of the Ministry of Water Resources, RD&GR for the year 2017-18.

5. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of the two officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-EIV (B) dated 5.8.1976.

6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.
