ORDER

Subject: Visit of Shri Rahul Kumar Singh, Senior Joint Commissioner (MI), MoWR, RD & GR to attend Asia Water Forum 2018 to be held at Asian Development Bank (ADB) Headquarters, Manila, Philippines, during 2-5 October, 2018 (excluding travel time).

Sanction of the competent authority is hereby accorded to the deputation of Shri Rahul Kumar Singh, Senior Joint Commissioner (MI), MoWR, RD & GR to attend Asia Water Forum 2018 to be held at Asian Development Bank (ADB) Headquarters, Manila, Philippines, during 2nd-5th October, 2018 (excluding travel time).

2. ADB will bear the restricted economy class round trip air ticket to Manila, allowances for miscellaneous travel expenses, accommodation and daily subsistence allowance for duration of the event in accordance with ADB practices, rates and applicable rules. Therefore, no expenses on the above will be borne by Government of India.
3. The officer shall travel on official passport. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.
5. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
6. The officers shall submit a report about their visit to Ministry of External Affairs (Southern Division) and Ministry of Water Resources (EA & IC Division) within one month of their return to India.
7. This issues with the concurrence of IFD of MoWR, RD& GR *vide* their Diary No. 265/IFD/2018 dated 18.09.2018.
