As per Rule 16(2) of AIS (Conduct) Rules, 1968, all the members of the IAS are required to submit their Immovable Property Returns (IPRs) (as on 1<sup>st</sup> January) every year, latest by 31<sup>st</sup> January.

- You would be aware that online filing of IPR was introduced since last year in respect of IAS officers. An IPR Module has been designed for the purpose which is already operational w.e.f 01.1.2017. The officer also has the option to upload the hard copy of the IPR by 31st January in the IPR Module.
- Those officers who file their IPR online or have uploaded the hard copy in the IPR Module by 31st January are not required to send a hard copy either to their Cadre or to DoPT.
- In view of the DoPT's instructions dated 04.4.2011, it is reiterated that failure to ensure timely submission of IPR would result in denial of Vigilance Clearance.
- I would, therefore, request you to kindly issue necessary instructions to all IAS officers belonging to your Ministry/Department in this regard.
