**ORDER**

2. The Asian Development Bank (ADB), with the Australian Water Partnership (AWP), and International Water Centre (IWC) is jointly organizing the event. The learning week is funded by AWP and facilitated by IWC. No expenditure would be borne by the Department of WR,RD&GR.
3. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above-mentioned officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure's O.M. No.19036/7/75-E.IV (B) dated 5.8.1976.
4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Government of India.
5. Remuneration/Honorarium/Fees, if any, received by the officials during the visit will be governed by SR-11 & SR-12 (FR-SR Part-I) and Government of India orders printed there under.
6. The officers will travel on official/diplomatic passport. The officials shall submit a report about their visit to Ministry of External Affairs (Southern Division) and Department of Water Resources, RD & GR (EA&IC Division) within one month of their return to India.
7. This sanction issues with the concurrence of Integrated Finance Division of DoWR,RD&GR, *vide* their Diary No. 281/IFD/2019-20 dated 30.7.2019.
