
**ORDER**

The travel expenses and accommodation expenses in respect of the visit would be borne by project funds of the above mentioned DST-NERC/ EPSRC Indo UK project and hence, **there would be no financial liabilities on the part of NIH/ DoWR, RD & GR** and therefore, no supplementation/ expenditure will be borne by DoWR, RD & GR/NIH on this visit.
  3. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.
  4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.
  5. The officials shall travel on official / personal passport and shall submit a tour report to Ministry of External Affairs (Europe West Division) and to the Department of Water Resources, RD & GR's EA&IC Division within one month of their return to India.
  6. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
