

**ORDER**


**Subject: Visit of Sh. Binod Kumar, Director, National Mission for Clean Ganga, DoWR, RD & GR for participating in Global Green Hub Korea (GGHK), 2019 at Seoul during 17th to 19th September,2019 (excluding travel duration) – reg.**

Sanction of the competent authority in the Department of Water Resources, River Development & Ganga Rejuvenation, Ministry of Jal Shakti is hereby accorded to the deputation of Sh. Binod Kumar, Director (Coordination), National Mission for Clean Ganga for participating in Global Green Hub Korea (GGHK), 2019 at Seoul during 17th to 19th September,2019 (excluding travel duration).

2. Sh. Binod Kumar, Director, NMCG is sanctioned the following:
  - i. **Air Passage:** As per entitlement.
  - ii. **Daily Allowance:** USD 400 (@ USD 100 per day for 4 days). The Officer can draw DA either in India or from Embassy of India in Seoul, Korea.
  - iii. **Conveyance:** Internal travel is to be arranged by Embassy of India in Seoul, Korea. If the Mission is unable to make arrangements, taxi services may be availed for local trips (to be reimbursed on production of bill, wherever applicable).
  - iv. **Hotel Accommodation:** As per entitlement, to be arranged by Embassy of India in Seoul, Korea and raise the bills to DoWR, RD & GR.
  - v. **Airport tax/health insurance/ visa fees:** As per actual.
  - vi. **Mobile phone:** To be arranged by Indian High Commission and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018 to concerned PAOs.
  - vii. **Passport:** The officer shall travel on official passport.
3. The entire expenditure for the above visit would be met from Foreign Training Expenses Head of the DoWR, RD & GR (Sectt. proper).
4. The Officials shall travel on Official passports. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above Officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.
6. Remuneration/Honorarium/Fees, if any, received by the officer during the visit will be governed by SR-11 & SR-12 (FR-SR Part-I) and Government of India orders printed there under.

7. The Officer shall submit a report about their visit to Ministry of External Affairs (EA Division) and Department of Water Resources, RD & GR (EA&IC Division) within one month of their return to India.
