
**ORDER**

Subject: **Visit of 3 members Indian delegation led by Sh. Gajendra Singh Shekhawat, Hon'ble Minister of Jal Shakti to participate at the Israel-India Strategic Partnership on Water Event in Jerusalem on 18<sup>th</sup> Nov'2019 and to participate in WATEC 2019 in Tel-Aviv, Israel during 18th to 20th November 2019 (excluding travel time) – reg.**

Sanction of the President is hereby accorded to the deputation of the following five members' Indian delegation led by Sh. Gajendra Singh Shekhawat, Hon'ble Minister of Jal Shakti to participate at the Israel-India, Strategic Partnership on Water Event in Jerusalem on 18.11.2019, and to participate in WATEC 2019 in Tel-Aviv, Israel during 18th to 20th November 2019 (excluding travel time):

- i. Sh. Gajendra Singh Shekhawat, Hon'ble Minister of Jal Shakti, Government of India
  - ii. Sh. Bharat Lal, Additional Secretary, D/o Drinking Water & Sanitation
  - iii. Sh. Rajnish Dev Burman, PS to Hon'ble Minister of Jal Shakti.
2. The period of deputation of above-mentioned delegation will be from 18<sup>th</sup> to 20<sup>th</sup> November, 2019 (excluding journey time).
3. All the above Officers have been sanctioned the following:
- i. **Air Passage:** As per entitlement.
  - ii. **Daily allowance:** US\$ 300 (@US\$ 75 per day per person) for 4 days.
  - iii. **Conveyance:** Internal transportation in Israel will be arranged by the Indian Embassy in Tel Aviv, Israel and raise bills as per rules.
  - iv. **Hotel Accommodation:** As per entitlements for 4 days, to be arranged by the Indian Embassy in Tel Aviv, Israel, and raise bills as per rules.
  - v. **Entertainment allowance:** Rs.7,500/- (Rupees seven thousand five hundred only)- for Minister (Jal Shakti) if a requirement is projected by the Indian Embassy in Tel Aviv.
  - vi. **Gift Allowance:** As per protocol norms for Hon'ble Minister (Jal Shakti).
  - vii. **Contingencies:** As admissible for Hon'ble Minister of Jal Shakti being Head of the delegation.
  - viii. **Airport Tax:** As per actuals.
  - ix. **Airport Lounge:** Airport Lounge in Israel to be arranged/ hired in respect of whole delegation by the Indian Mission in Tel Aviv, Israel and raise bills as per rules.
  - x. **Mobile Phone:** To be arranged by Indian Embassy in Tel Aviv, Israel and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.
4. The expenditure on account of TA/DA in respect of the visit of Hon'ble Minister of Jal Shakti would be met from concerned Cabinet Secretariat's Foreign Visits Expenses Head for
