

2. The each of the above officers has been sanctioned the following:-

- Air Passage:** As per entitlement (No booking shall be made in first class).
- Daily Allowance:** US \$ 700 (@ US\$ 100 per day for 7 days). The DA will be provided by Indian Mission/ Embassy in the Spain.
- Conveyance:** Internal travel is to be arranged by Indian Mission/ Embassy in the Spain. If the Indian Embassy/Mission does not provide official vehicle for the local official travel, hiring of car is allowed for Secretary (WR, RD & GR). Rest of the delegation may avail local taxi services for the purpose (to be reimbursable on production of bills, wherever available).
- Hotel Accommodation:** As per entitlement, to be arranged by Indian Mission/ Embassy at the Spain.
- Airport tax/health insurance/ visa fees:** As per actual.
- Mobile phone:** To be arranged by Indian Mission/ Embassy and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.
- Gift:** On reciprocal basis only and to be regulated strictly as per extant instructions/ guidelines/ norms.

3. The expenditure on the above visit in respect of Secretary (WR, RD & GR) shall be borne under FTE head of MoWR, RD&GR for the year 2018-19. In respect of Shri S K Haldar, Member, CWC, the expenses shall be charged on FTE head of CWC for the year 2018-19. In respect of Shri Rakesh Kashyap, SJC, NHP the expenses shall be charged on FTE head of NHP for the year 2018-19. only if scheme related activity/component is involved in visit else the same shall be charged to FTE head of MoWR, RD&GR for the year 2018-19.
