ORDER

Subject: Deputation abroad of a five-members delegation from MoWR, RD&GR to Rabat, Morocco for attending 2nd India - Morocco Joint Working Group Meeting to be held during 18-21 June, 2019 (excluding travel time).

Sanction of the Competent Authority in Ministry of Water Resources, River Development and Ganga Rejuvenation is hereby accorded to the deputation of following 5-member team to Rabat, Morocco for attending 2nd India - Morocco Joint Working Group Meeting to be held during 18-21 June, 2019 (excluding travel time):

- a) Dr. B. R. K. Pillai, Commissioner (CAD), MoWR, RD & GR - Head of the delegation
- b) Shri Manoj Tiwari, Director, Central Water Commission, MoWR, RD & GR
- c) Shri. Subba Rao Dodda, Director, Central Ground Water Board, MoWR, RD&GR
- d) Shri. Ashish Kumar, Director (GW), MoWR, RD&GR
- e) Shri Mukesh Kumar, Deputy Secretary (EA&IC), MoWR, RD&GR

2. Each of the above officer has been sanctioned the following:

- (i) **Air Passage:** As per entitlement.
- (ii) **Daily Allowance:** US \$ 300 (@ US\$ 60 per day for 5 days). DA can be drawn either in India (MoWR) or from Indian Embassy in Rabat, Morocco.
- (iii) **Conveyance:** Internal travel is to be arranged by Indian Mission/ Embassy in the Morocco. If the Indian Embassy/Mission does not provide official vehicle(s) during the visit, the officers may avail local taxi services for local official trips (reimbursable on production of receipt), wherever available
- (iv) **Hotel Accommodation:** To be arranged by Indian Mission / Embassy in Rabat, Morocco and raise the bills to MoWR, RD&GR as per rules.
- (v) **Airport tax/health insurance/ visa fees:** As per actual.
- (vi) **Mobile phone:** To be arranged by Indian Mission/ Embassy and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.

3. The expenditure on the above visit may be charged to Foreign Travel Expenses (FTE) of the Ministry of Water Resources for the year 2019-2020.

4. The period of absence from the post in India and grant of pay and allowances and counting of increment for the above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No.19036/7/75-E.IV (B) dated 05.08.1976.

5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt. of India.

6. The officials shall travel on official/ diplomatic passport and shall submit a tour report to Ministry of External Affairs (WANA Division and Coord Division) and the Ministry of Water Resources (EA&IC Division) within one month of his return to India.

7. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
