ORDER

Subject: Deputation of Dr.(Mrs) Archana Sarkar, Scientist 'D', NIH, Roorkee to participate in the "Inclusive Capacity Development in Water Forecasting and Climate Change Adaptation Showcase" at World Water Week in Stockholm, Sweden during 23-27 August, 2019 – reg.

Sanction of the competent authority is hereby accorded to the deputation of Dr. (Mrs) Archana Sarkar, Scientist 'D', NIH, Roorkee to participate in the "Inclusive Capacity Development in Water Forecasting and Climate Change Adaptation Showcase" at World Water Week in Stockholm, Sweden during 23-27 August, 2019 (excluding travel time).

2. The Swedish Meteorological and Hydrological Institute (SMHI) has invited the officer to participate in the showcase at the World Water event in Stockholm and the preparation meeting will take place at SMHI, Norrkoping prior to and after the showcase.

3. There is no financial liability on the GoI as all the expenses covering the round trip air tickets, boarding and lodging will be borne by SMHI. The visit is treated as official, and hence, the officer shall travel on official passport.

4. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above-mentioned officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure's O.M. No.19036/7/75-E.IV (B) dated 5.8.1976.

5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt of India.

6. Remuneration/Honorarium/Fees, if any, received by the officer during the visit will be governed by SR-11 & SR-12 (FR-SR Part-I) and Government of India orders printed there under.

7. The official shall submit a report about her visit to Ministry of External Affairs (Central Europe Division) and DoWR, RD & GR (EA&IC Divion) within one month of their return to India.

8. This sanction issues with the concurrence of Integrated Finance Division of DoWR,RD&GR, *vide* their Diary No.332 /IFD/2019-20 dated 19.8. 2019.
