

4. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above-mentioned officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure's O.M. No.19036/7/75-E.IV (B) dated 5.8.1976.
5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officials will not stay abroad under any circumstances beyond the approved period without the prior sanction of Govt of India.
6. Remuneration/Honorarium/Fees, if any, received by the officer during the visit will be governed by SR-11 & SR-12 (FR-SR Part-I) and Government of India orders printed there under.
7. The official shall submit a report about his visit to Ministry of External Affairs (Northern Division) and DoWR, RD & GR (EA&IC Divion) within one month of their return to India.


