Subject: Visit of 4 members' delegation from DoWR, RD&GR for participating in World Water Week 2019 scheduled to be held in Stockholm, Sweden during 25th to 30th August 2019 (excluding travel time).

Sanction of the competent authority in the Department of Water Resources, River Development & Ganga Rejuvenation, Ministry of Jal Shakti is hereby accorded to the deputation of following four officials from DoWR, RD & GR for participating in World Water Week-2019 scheduled to be held in Stockholm, Sweden during 25th-30st August 2018 (excluding travel time).

 - iii. Mr.P.M. Scott, Chief Engineer, Shillong , Central Water Commission
 - iv. Mr.Anoop Nagar, Regional Director, Chandigarh, Central Ground Water Board
2. The officers mentioned above are sanctioned the following:-
- i. **Registration Fees:** SEK 9500 per person.
 - ii. **Air Passage:** As per entitlement.
 - iii. **Daily Allowance:** US\$ 700 per person (@US\$ 100 per day for 7 days). The officers can draw the DA either in India or from Indian Embassy in Stockholm, Sweden.
 - iv. **Conveyance:** Internal travel is to be arranged by Indian Embassy in Stockholm, Sweden. If the Mission is unable to make arrangements, taxi services may be availed for local trips (to be reimbursed on production of bill, wherever applicable).
 - v. **Hotel Accommodation:** As per entitlement, to be arranged by Indian Embassy in Stockholm, Sweden and raise the bills to concerned PAOs of NMCG/NWM/CWC/ CGWB.
 - vi. **Airport tax/health insurance/ visa fees:** As per actual.
 - vii. **Mobile phone:** To be arranged by Indian High Commission and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018 to concerned PAOs.
 - viii. **Passport:** The officer shall travel on official/diplomatic passport.
3. The expenditure in respect of Sh. Rajiv Ranjan Mishra, DG would be met from FTE Head of the DoWR, RD & GR (proper) except for the registration Fee charges which would be charged from OAE head of the DoWR, RD & GR (proper), Ministry of Jal Shakti. The Expenditure in respect of other Officers listed at S.No. (ii) to (iv) would be met from FTE Head of concerned Organization except for the registration fee charges which would be met from OAE Head of the concerned Organization. All the above-mentioned Officers are requested to register online (<https://www.worldwaterweek.org/engage/register>) for their participation in the event themselves and may claim their registration Fees from their respective Cash Section/ PAOs.
