ORDER

Subject: Visit of 2 CWPRS officials to Bhutan for carrying earthquake studies for Kuri-Gongri H.E. Project, Bhutan during 25th November – 20th December 2019 (including travel time)

2. All the expenditure (including TA/DA etc.) on the above visit shall be charged to the Deposit Work Estimate awarded by M/s WAPCOS Ltd. and therefore, no expense will be borne by DoWR, RD&GR/ CSMRS in respect of the above visit.

The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.
5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
6. The officers shall submit a report about their visit to Ministry of External Affairs (Northern [Nepal, Bhutan] Division) and Department of Water Resources, RD&GR (EA & IC Division) within one month of their return to India.
