**ORDER**

**Subject: Deputation abroad of Shri Shyam Lal Meena, Director (NWIC), CWC to attend short term training programme in USA under DFFT Scheme of DoP&T for the year 2019-20.**

Sanction of the competent authority is hereby accorded to the deputation Shri Shyam Lal Meena, Director (NWIC), Central Water Commission to USA for attending short term training programme at University of California-Berkeley (UCB)'s four-months 'Certificate Programme in Public Policy' to be held from 12<sup>th</sup> January 2020 to 05<sup>th</sup> May 2020 under Domestic Funding of Foreign Training Scheme of Department of Personnel & Training for the year 2019-20.

2. The entire period of the training programme commencing from the date of departure from India till the return shall be treated as on 'duty' and salary for this period will be paid by Central Water Commission.

3. As mentioned by DoP&T in its DO No. 12037/33/2019-FTC(Trg) dated 09.12.2019, Govt of India (Deptt of Personnel & Training) will bear the expenditure of the training programme, including the cost of air travel for the Delhi-San Fransico (USA)-Delhi sector.


4. The above officer may claim the pre-departure expenses like visa fees, requisite insurance, airport taxes and conveyance charges between Air Port and place of residence withing India and abroad as reimbursement from the Central Water Commission. These expenses shall be charged to Foreign Travel Head of the Central Water Commission for the year 2019-20.

5. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of the officer will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.

7. The officer shall submit a report about his visit to Ministry of External Affairs (C.A.M.S Division), Department of Personnel and Training (Training Division) and Department of Water Resources (EA & IC Division) within one month of his return to India.
