**ORDER**

**Subject: Visit of Shri Sunil Kumar, Director, Central Water Commission for attending the first G-20 Agriculture Deputies Meeting (Food & Water) to be held on 26-27 January, 2020 (excluding travel time) in Riyadh, Saudi Arabia**

3. The above expenditure on the visit of shall be borne by Central Water Commission, under its Foreign Travel Head for the year 2019-20.

4. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.

5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.

6. The officers shall submit a report about his visit to Ministry of External Affairs (Gulf Division) and Department of Water Resources, RD & GR (EA & IC Division) within one month of their return to India.
