- e) **Airport tax/health insurance/ Visa fees:** As per actual, if any.
- f) **Internal Transport:** Transportation in United Kingdom for the purpose of this visit, to be provided by Indian High Commission in United Kingdom and raise the bills as per rules.

3. The above expenditure on the visit of shall be charged on major Head No. 3451.00.090.16.01.12 of DoWR, RD & GR (Secretariat proper), Foreign Travel Expenses of the Department of Water Resources, RD & GR for the year 2021-22.

4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.

5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.

6. The officers shall submit a report about their visit to Ministry of External Affairs (Europe West Division) and Department of Water Resources (EA & IC Division) within one month of their return to India.
