ORDER

Subject: Visit of 3 member delegation led by Shri Gajendra Singh Shekhawat, Hon'ble Minister for Jal Shakti to participate in the 4th Asia Pacific Water Summit (APWS) scheduled to be held at Kumamoto City, Japan during 23-24 April, 2022 (excluding travel time). – reg.

Sanction of the President is hereby accorded to the deputation of the following three members Indian delegation led by Sh. Gajendra Singh Shekhawat, Hon'ble Minister for Jal Shakti to participate in the 4th Asia Pacific Water Summit (APWS) scheduled to be held at Kumamoto City, Japan during 23-24 April, 2022 (excluding travel time):

- i. Shri Gajendra Singh Shekhawat, Hon'ble Minister for Jal Shakti
- ii. Shri Gopala Pillai Asok Kumar, Director General, National Mission for Clean Ganga
- iii. Shri Chaudhari Uday Gaurishankar, PS to Hon'ble Minister for Jal Shakti

2. All the above officers have been sanctioned the following:

- i. **Air Passage:** As per entitlement (Delhi-Japan-Delhi).
- ii. **Daily allowance:** US\$ 900 (@US\$ 100 per day per person) for 3 days.
- iii. **Conveyance:** Internal transportation in Japan to be arranged by the Indian Embassy in Tokyo, Japan and raise bills as per rules. If the Embassy is not able to provide official vehicle, hiring of car is allowed for Hon'ble Minister accompanied by his PS and DG, NMCG.
- iv. **Hotel Accommodation:** As per entitlements, to be arranged by the Indian Embassy in Tokyo, Japan and raise bills as per rules.
- v. **Entertainment allowance:** Rs.7,500/- for Hon'ble Minister for Jal Shakti if a requirement is projected by the Indian Embassy in Tokyo, Japan.
- vi. **Gift Allowance:** As per protocol norms for Hon'ble Minister for Jal Shakti.
- vii. **Contingencies:** As admissible for Hon'ble Minister for Jal Shakti being Head of the delegation.
- viii. **Airport Tax/Health Insurance/Visa Fees:** As per actual.
- ix. **Airport Lounge:** VIP airport Lounge in Japan to be arranged in respect of whole delegation by the Indian Embassy in Tokyo, Japan and raise bills as per rules.
- x. **Mobile Phone:** To be arranged by Indian Embassy in Tokyo, Japan and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.
- xi. **Participation Fee:** As per actual.

3. The expenditure on account of TA/DA in respect of the visit of Hon'ble Minister for Jal Shakti would be met from concerned Cabinet Secretariat's Foreign Visits Expenses Head for Council of Ministers. All other expenses in respect of the visit of the delegation may be charged from Major Head No. 3451.00.090.16.01.12 of DoWR, RD & GR (Secretariat proper) - Foreign Travel Expenses of the Department of Water Resources, RD&GR for the year 2022-23.

4. The Embassy of India in Tokyo, Japan shall provide necessary assistance/ logistic supports as required by Hon'ble Minister of Jal Shakti during his visit abroad. The Embassy of India in Tokyo, Japan is requested to arrange hotel accommodation, staff car and protocol arrangement for the above delegation as per entitlement. The Embassy of India in Tokyo, Japan is also requested to arrange daily allowances, entertainment, contingencies, mobile sim, gifts etc. as admissible to the delegation.
