Subject: Visit of 3 member Indian delegation led by Shri Gajendra Singh Shekhawat, Hon'ble Minister for Jal Shakti to Denmark to participate in IWA World Water Conference & Exhibition in Copenhagen, Denmark during 12-13 September, 2022 and subsequent visit of DG, NMCG to Germany for bilateral meetings with GIZ during 14-15 September, 2022 (excluding travel time) - reg.

Sanction of the President is hereby accorded to (i) the deputation of the following three members Indian delegation led by Sh. Gajendra Singh Shekhawat, Hon'ble Minister for Jal Shakti to participate in High level "IWA SDG Summit" in IWA World Water Conference & Exhibition in Copenhagen, Denmark during 12-13 September, 2022 and (ii) subsequent visit of Director General, NMCG to Germany for bilateral meetings with GIZ during 14-15 September 2022 (excluding travel time):-

- Air Passage:** (i) In respect of Hon'ble MoJS and PS to Hon'ble MoJS - As per entitlement (Delhi – Denmark - Delhi) & (ii) I.r.o. DG, NMCG - As per entitlement (Delhi – Denmark – Germany - Delhi)
- Daily allowance:** (i) In respect of Hon'ble MoJS and PS to Hon'ble MoJS - US\$ 600 (@US\$ 100 per day per person) for 3 days & (ii) I.r.o. DG, NMCG - US\$ 500 (@US\$ 100 per day per person) for 5 days.
- Conveyance:** Internal transportation in Denmark & Germany to be arranged by the Indian Embassy in Denmark & Germany & raise bills as per rules.
- Hotel Accommodation:** As per entitlements, to be arranged by the Indian Embassy in Denmark & Germany and raise bills as per rules.
- Entertainment allowance:** Rs.7,500/- for Hon'ble Minister for Jal Shakti if a requirement is projected by the Indian Embassy in Denmark.
- Gift Allowance:** As per protocol norms for Hon'ble Minister for Jal Shakti.
- Contingencies:** As admissible for Hon'ble Minister for Jal Shakti being Head of the delegation.

ix. **Airport Lounge:** VIP airport Lounge in Denmark to be arranged in respect of whole delegation by the Indian Embassy in Denmark and raise bills as per rules.
x. **Mobile Phone:** To be arranged by Indian Embassy in Denmark and Germany and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.

3. The expenditure on account of TA/DA in respect of the visit of Hon'ble Minister for Jal Shakti would be met from concerned Cabinet Secretariat's Foreign Visits Expenses Head for Council of Ministers. All other expenses in respect of the visit of the delegation may be charged from Major Head No. 3451.00.090.16.01.12 of DoWR, RD & GR (Secretariat proper) - Foreign Travel Expenses of the Department of Water Resources, RD&GR for the year 2022-23.

4. The Embassy of India in Denmark shall provide necessary assistance/ logistic supports as required by Hon'ble Minister of Jal Shakti during his visit abroad. The Embassy of India in Denmark is requested to arrange hotel accommodation, staff car and protocol arrangement for the above delegation as per entitlement. The Embassy of India in Denmark/Germany is also requested to arrange daily allowances, entertainment, contingencies, mobile sim, gifts etc. as admissible to the delegation.

5. The above officers shall travel on Diplomatic/ Official passports. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above-mentioned Officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/775-E.IV (B) dated 5.8.1976.


6. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers shall not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction/ approval of Government of India.

7. The other entitlement, if any, shall be in accordance with the Ministry of Finance, Department of Expenditure's O.M. No.19036/7/84-E.IV dated 21.08.1985 as amended from time to time.

8. Remuneration/honorarium/fees, if any, received by the official during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.

9. The delegation shall submit a report about the visit to Ministry of External Affairs {Central Europe Division} & {Europe West Division} and Department of Water Resources, RD & GR (EA&IC Division) within one month of return to India.

10. This issues with the approval of PMO vide their I.D. Note No. 3561876/PMO/2022 dated 10.09.2022, Screening Committee of Secretaries, Department of Expenditure's approval vide ID Note No. 2809875/E.Coord/2022 dated 10.09.2022 and with the concurrence of IFD of DoWR,RD&GR vide their Diary No. 503/IFD/2022-23 dated 01.09.2022.
