4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances beyond the above-mentioned approved period without the prior sanction of Government of India.
5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Order printed there under.
6. The officers shall submit a report about their visit to Ministry of External Affairs (Americas Division) and Department of Water Resources, RD & GR (EA&IC Division) within one month of his return to India.




