

5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
6. The officer shall submit a report about his visit to Ministry of External Affairs (East Asia Division) and D/o Water Resources, RD & GR (EA & IC Division) within one month of their return to India.
