2. The above officers have been sanctioned the following:
- a) **Air Travel:** As per entitlement.
 - b) **Daily Allowance:** US\$ 300 each (@ \$60 per day for 5 days) to be arranged by India Mission in Nepal.
 - c) **Hotel Accommodation:** As per entitlement.
 - d) **Mobile:** To be arranged by India Mission in Nepal and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.
 - e) **Airport tax/health insurance/ Visa fees:** As per actual, if any.
3. The above expenditure on the visit of shall be charged on Head No. 451.00.090.81.00.12 – Foreign Travel Expenses of the Office of the Controller of Accounts, DoWR, RD & GR, M/o Jal Shakti.
4. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above-mentioned Officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 1903617175-E.IV (B) dated 5.8.1976.
5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will not stay abroad beyond the above-mentioned period under any circumstances without the prior sanction of Government of India.
6. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Orders printed there under.
7. It has been advised by MEA that auditors travelling to Nepal for auditing JPO-SKSKI need to work in close coordination with Indian Embassy in Kathmandu as the Auditor's Report shall be shared with Government of Nepal, which may have political implications.
