Sanction of the competent authority is hereby accorded to the deputation of Ms. Debashree Mukherjee, Special Secretary (WR,RD&GR) to participate in Water Week organized by Water Global Practice (GP) of World Bank Group during 27 Feb - 1 March, 2023 at World Bank HQs in Washington DC, USA (excluding travel time).

2. The above officer has been sanctioned the following:
 - i. **Air Passage:** As per entitlement (Delhi → USA → Delhi).
 - ii. **Daily allowance:** US\$ 400 (@US\$ 100 per day per person) for 4 days.
 - iii. **Conveyance:** Internal transportation in USA to be arranged by the Indian Embassy in USA & raise bills as per rules.
 - iv. **Hotel Accommodation:** As per entitlements, to be arranged by the Indian Embassy in USA & raise bills as per rules.
 - v. **Airport Tax/Health Insurance/Visa Fees:** As per actual.
 - vi. **Mobile Phone:** To be arranged by Indian Embassy in USA and raise bills as per MoF Circular No. 24(3)/E.Coord./2018 dated 26.03.2018.
3. The entire expenditure on the visit shall be charged from Major Head No. 3451.00.090.16.01.12 of DoWR, RD & GR (Secretariat proper) - Foreign Travel Expenses of the Department of Water Resources, RD&GR for the year 2022-23.
4. The above officer shall travel on Diplomatic/ Official passports. The period of absence from the post in India and grant of pay and allowances and counting of services for increment of above-mentioned Officers will be regulated in accordance with the provisions of Para 13-15 of the Ministry of Finance, Department of Expenditure O.M. No. 19036/7/75-E.IV (B) dated 5.8.1976.
5. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officers shall not stay abroad under any circumstances beyond the above-mentioned approved period without the prior sanction/ approval of Government of India.
6. The other entitlement, if any, shall be in accordance with the Ministry of Finance, Department of Expenditure's O.M. No.19036/7/84-E.IV dated 21.08.1985 as amended from time to time.
