- f. **Internal Transport:** Transportation in Republic of Korea for the purpose of this visit, to be provided by Indian Mission in Republic of Korea and raise the bills as per rules.

3. The above expenditure on the visit of shall be charged on major Head No. 3451.00.090.16.01.12 of DoWR, RD & GR (Secretariat proper), Foreign Travel Expenses of the Department of Water Resources, RD & GR for the year 2023-24.

4. The resignation or request for voluntary retirement from service while abroad will not be entertained under any circumstances. The officer will
