

A meeting was held under the chairpersonship of Deputy Secretary (Admn) at 10:30 AM on 8th February, 2024 in the Chamber of Deputy Secretary (Admn) to discuss the pending matter of MTS Benevolent Fund.

2. To extend help to the employees of this Department at the time of great financial distress a Contributory Benevolent fund was established during 1996. As per Sr. No. 11(a) of Rules and Regulation of the fund were framed.

3. In view of above, following deliberations have been made: -

- i. To make a deduction of Rs 100 per month, per person to be added in the MTS Benevolent

- ii. Officials who were earlier of MTS Benevolent Fund should be revived and again be made members.
(Action: GA, DoWR, RD & GR)

- iv. Amount of money that is given as aid to beneficiaries should be increased and for that separate meeting will be held in due course of time.

- v. MTS association requested that the cadre of MTS that are recruited in CWC and Sectt. should be maintained individually.
(Action: Admn, DoWR, RD & GR)
- vi. MTS association requested that they should be considered for training workshops; however chair suggested that they can undertake online training on iGot Karmayogi portal which is an initiative of Dopt. that provides anytime-anywhere-any-device learning. Moreover, letters have been written to National Water Academy and NERIWALM to conduct training programmes for MTS.

- vii. MTS association requested for regularization of Vijay Ram, Sameer Singh, Arun Kumar and Harish Kumar but as the matter is pending with Hon. High Court therefore no action is required as of now.
