4. The resignation or request for voluntary retirement from service while abroad shall not be entertained under any circumstances. The officer shall not stay abroad beyond the above-mentioned period under any circumstances without the prior sanction of the Government of India.

5. Remuneration/honorarium/fees, if any, received by the officials during the visit will be governed by SR-11 and SR-12 (FR-SR. Part-I) and Government of India Order printed there under.

6. The officers shall submit a report about their visit to the Ministry of External Affairs (Central Europe Division) and Department of Water Resources, RD & GR (EA&IC Division) within one month of their return to India.
